

Privacy Statement

This statement (the "**Privacy Statement**") sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by Angelman Syndrome Ireland Limited ("**Angelman Syndrome Ireland**"). By visiting the Angelman Syndrome Ireland website, you are accepting the terms of this Privacy Statement. This website contains external links to other websites and Angelman Syndrome Ireland is not responsible for the privacy policies of these other websites.

Angelman Syndrome Ireland fully respects your right to privacy, and will not collect any personal information about you on this website without your clear permission. Any personal information which you volunteer to Angelman Syndrome Ireland will be treated with the highest standards of security and confidentiality, strictly in accordance with the Data Protection Acts, 1988–2003 (the "Act"). For the purpose of the Act, the data controller is Angelman Syndrome Ireland Limited, a company limited by guarantee without a share capital registered in Ireland with company number 506106 and its registered address at Ecka House, Old Road, Tuam, Co. Galway

1. What type of information do we collect?

Angelman Syndrome Ireland may collect and process information and personal data about you when you register on our website, subscribe to our newsletter, fill out a form, make a donation, enter a competition or report a problem with our site. Such personal data may include personal details such as your name, e-mail address, postal address, phone number, as well as details regarding your personal experience of Angelman Syndrome as applicable. Any information which you provide in this way is not made available to any third parties, and is used by Angelman Syndrome Ireland only in line with the purpose for which you provided it, including in anonymised format for research and statistical purposes. Angelman Syndrome Ireland may also collect technical data about your visits to our site from time to time. Angelman Syndrome Ireland will make no attempt to identify individual visitors or to associate any technical details collected with any individual.

2. How do we protect your information?

Angelman Syndrome Ireland will take all reasonable precautions including strict security procedures to prevent the loss, misuse, alteration or unauthorised access to information you give us and will only use the data for the intended purpose. Agents or contractors of Angelman Syndrome Ireland who have access to information you give us in the course of providing services to us are required to keep that information confidential and are not permitted to use it for any purpose other than to carry out the services which they are performing for us. You should note however, that internet transmissions are never completely private or secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site and any transmission is at your own risk.
